To ensure a smooth and efficient verification process, please follow the submission guidelines for verification of diamonds. Following these guidelines will help ensure that your stones are processed accurately and efficiently, and that you receive the information and feedback you need to make informed decisions about your stones in a timely manner.

- 1. Please provide accurate and detailed information about the Stone/s, including its weight, size, shape, and any other relevant characteristics.
- 2. Submit DMIA Member number, company name, address, email, phone number and contact on the submission form.
- 3. If larger than 1.00ct please include any certification or grading reports for the stone from reputable organizations such as GIA or AGS, if you have one.
- 4. Stones larger than 1ct must be in separate parcel papers or polybags with diamond shape and weight indicated.
- 5. Melee or breakout parcel submission minimum requirement is 1ct total weight of goods.
- 6. Goods under 0.18 MUST be sorted by MM size. Please see reference chart.
- 7. Please make sure to sort stones under 1ct by carat range. See table for suggested separation below.
- 8. Please make sure stones are clean when submitting. If diamonds are submitted without noticeably clean, they will be promptly returned with no service provided.
- 9. Goods will be returned in the condition they are received. IGI is not responsible for broken chipped or damaged stones.
- 10. Additional Services are offered. Please inquire.
